





# Capacity building is inherent in both Project Stages

# Sep, 2021-April, 2022

Regulatory review

Stage 1

- Background information collection
- Baseline environmental sampling, analysis, and mapping
- Stakeholder engagement (Goals and Objectives)
- Risk identification and assessment



# June, 2022-TBD: Prepare Closure Plan for Salkhit Silver Mine

- Significant scientific and engineering effort, and financial commitment, will be required by the mining Company to complete Stage 2.
- Close collaboration between government, industry, consultants, and key stakeholders will be critical during Stage 2



# Goal 1: Write a mine closure plan for Erdenes Silver Resources LLC Salkhit Silver Mine

#### **Objectives:**

- 1.1 Innovative, incorporating international best practice
- 1.2 Includes gender equality principles
- 1.3 Realistic and economically achievable
- 1.4 Supports socio-economic transition after mine closure
- 1.5 Responsive to climate change through adaptation
- 1.6 Supports improvement of laws and regulations guiding mine closure





# Goal 2: Enhance knowledge and competencies of planning team members, stakeholders and local citizens

#### **Objectives:**

- 1.1 Implement learning opportunities, fulfilling team member and stakeholder needs
- 1.2 Improve knowledge of international best practices, new techniques and technologies
- 1.3 Local citizens, herders and community representatives are informed, improving their capability to meaningfully engage



 The evidence-base formed through this experience will inform government and industry of potential areas to strengthen guiding laws and regulations and build capacity for their implementation.







- The final Mine Closure Plan can be used as a model for future closure plans in Mongolia that contributes to efficiency at the company level and reduced liability and costs for government.
- It can showcase the capacity of state-owned mining companies to perform as leaders in mine closure planning.





• The pilot will create access to cutting-edge climate change work, plying best practice in rehabilitation and climate-resilient vegetation.





 Communication on the pilot can show stakeholders, including communities and civil society, that the government and industry are promoting responsible mine closure

 Consultation with stakeholders from the beginning will keep them informed and updated on the process which will promote buy-in and support towards closure outcomes.





Timely support for the Mongolian government to:

- Strengthen confidence in the mining sector
- Support the Economic Recovery Policy and the government's long-term plan, Vision 2050
- Identify how the sector can support climate change initiatives
